List of topics covered	Course topics will include a range of social issues, such as: - financial hardship and poverty, - social classes,
	ageism,youth and antisocial conduct,crime and punishment in society.
	The core syllabus will be topic based or thematic, with occasional elements from other syllabus types, such as structural and functional. The lessons will be organised around a chosen topic to which language, activities, and skills will be connected. The course will include vocabulary development and grammar review or reinforcement at a C1 level of the Common European Framework (subject to modification as needed to best serve student needs).

Learning outcomes

As regards **knowledge and understanding**, on completion of the course students are expected to:

- have promoted their discipline-specific lexica knowledge with regard to the course topics;
- demonstrate comprehension of texts read in class, mastering specific lexical items that occurred;
- have deepened their knowledge of certain aspects of academic language and style in written texts.

As regards **applying knowledge and understanding**, on completion of the course students are expected to:

- show their knowledge and understanding of texts read in class by synthesising points raised by writers, using appropriate vocabulary;
- apply the knowledge acquired through course content to form opinions and support arguments on a range of social issues;
- apply their knowledge of key lexical and grammatical features in their spoken interactions in a range of contexts.

As regards **making judgements**, on completion of the course students are expected to:

- show an ability to think critically about issues dealt with in the course;
- be able to form judgements on the basis of texts;
- demonstrate an awareness and understanding of multiple points of view;
- demonstrate an awareness of certain linguistic characteristic features of texts.

As regards **communication skills**, on completion of the course students are expected to:

- convey knowledge using extensive vocabulary and appropriate grammatical structures (general and specific to the field);
- be able to maintain active discussions on the topics dealt with, clearly expressing and sustaining a viewpoint;
- communicate their ideas and opinions on the aspects dealt with in the course using academic language, hedging statements, and referring to relevant literature.



	As regards learning skills, on completion of the course students are expected to: - show an ability to take notes and organise course content effectively; - show an ability to draw connections between issues raised; - display an ability to select and exploit course readings; - be able to consult reference materials and to integrate them appropriately into their work.
Assessment	Oral exam In the exam, students will have to answer specific as well as general questions on the topics dealt with in the course. Students' knowledge, vocabulary, fluency, and accuracy will be assessed. The evaluation rubric will be made available at the beginning of the course.
