Course description:	The methodological expertise of social workers, while being based on scientific evidence, is only professionally acceptable when it respects the dignity of the person to whom it refers. The engagement with that person is therefore both an ethical and a practical issue in the identification of appropriate methods, and a focus on the nature of this participative process is essential in social work methodology. At the same time this also requires special attention to the evaluation and the criteria for evaluation of one's intervention results which need to be built around the same principles of a critical, interactive engagement with the users of social services.
Specific educational objectives:	Basic discipline: Social work methodology Caratterizzanti: social politics Participants will widen their methodological repertoire of methods of intervention and evaluation in the light of the above principles. In particular, they will learn to incorporate an ongoing process of research into their practice with different client groups and in different situations.

The focus is on a research based evaluation of the presented case (30%) c) in the form of an written summary of a chosen key text with an discussion of the theoretical elements thereby used as foundation for the understanding of different forms and levels of participation and praxis evaluation (40%)
