Specific educational objectives and course description	<p>The course belongs to the class “optional” in the curriculum in Design and in the curriculum in Art.</p> <p>The course introduces artistic strategies to deal with and define ‘space’. To one part it focuses on influential artists and their spatial practices (A. Kaprow, R. Morris, D. Graham, M. Broodthaers, A. Piper, a.o.); on the other part the course confronts with major theoretical texts from art theory, philosophy and sociology, which inspired the artists or reflect their achievements. Major concepts related to spatial practice are discussed: Participation, contextuality, institutional critique, public, interventionist practices, relational aesthetics.</p> <p><i>Educational objectives:</i></p> <ul style="list-style-type: none"> • the acquisition of the basic knowledge concerning space as socially constructed connected to the possibilities of artistic ‘deviance’ • to have the ability to structure a clearly defined field of knowledge
