Course description	<ul> <li>The aim of this course is to introduce and secure an understanding of music making and learning and the creative and artistic skills to facilitate musical activity with others through projects and events.</li> <li>Transferable skills in communication, organisation, self-resilience, leadership, teamwork and evaluation needed in the execution of Music learning and making will be investigated.</li> <li>An awareness and understanding of distinctive traditions, conventions, practices and contexts that have helped shape contemporary practice within music making and learning will be developed.</li> <li>Students will also become familiar with current trends and developments in Music learning and making music.</li> </ul>
Specific educational objectives	<ul> <li>The course gives a <i>general</i> overview of the basic principles and goals of Music making and learning. This includes an overview of the history, current developments and career paths in the field of Music learning and making.</li> <li>Various approaches, contents and methods and relevant literature will form the foundation of the course.</li> <li>The educational objectives of this course are: <ul> <li>To explore the challenges of Music learning and making in the 21<sup>st</sup> Century and dealing with diverse communities, and therefore the aims and objectives of Music learning and making.</li> <li>To understand the purpose of Music Education and Community Music.</li> <li>To explore the complex role of music in our society and culture.</li> </ul> </li> <li>To consider the impact of the arts on occupational and life skills, and individual psychological wellbeing.</li> </ul>

Evaluation criteria and criteria for awarding marks	Composition of the final mark: 1. Two written paper: one on a topic about learning music and one about making music.

The coordinator of the modules is responsible for the provided data.)	<ul> <li>The following points might help in writing the paper: demonstrate how well you can write material in the context of the course; identify the main issues it raises; give a clear, succinct account of those issues; and present a reasoned judgment regarding the soundness of the views.</li> <li>Is there an explicit theoretical framework? Concepts: what are the central concepts? Are they clearly defined? Argument: what is the central argument? Are there specific hypotheses?</li> <li>Contribution: how well does the paper advance our knowledge of the subject?</li> <li>The following criteria will be used in assessing the paper review:</li> <li>Expression, grammar, spelling.</li> <li>Does the piece answer all parts of the question? Clear evidence of critical thinking.</li> <li>Is it clear and well structured?</li> <li>Is there an argument? Is it convincing and evidencebased?</li> <li>Does it follow the prescribed formatting instructions? Additional wow-factor?</li> </ul>
	<ul> <li>2. Oral exam During the oral examination the following will form part of the examination: Questions and reflection on the paper.</li> <li>The student will be asked to evaluate, argue and critically analyse and reflect on accumulated knowledge and experiences through answering relevant questions based on coursework.</li> </ul>
