Course description:	The course on Information Literacy has three parts.  Part I deals with Information Literacy Standard competencies according to the International Guidelines for Higher Education & PhD programs.					
	Part II and III deal with bibliometric fields of application: selection of journals, publication process and bibliometric indicators.  Part II focuses on low quality and predatory journals, their characteristics and their significance in the research context. The course comments on the individual steps of a publication process and shows the differences between low and high quality journals.  Part III deals with high quality journals and their selection criteria in the Italian research context. Students will learn about the relevant journal lists and databases that support the selection process and they will evaluate journals according to evaluation criteria. Additionally, they will become familiar with the most important bibliometric (evaluation) indicators and they will take the first steps towards journal selection.
