<b>Teaching format</b>	The explanation of the background material will be made through videos that the students are expected to have watched before coming to class. Class time will be spent on examples, exercises and case discussions. Students will be expected to participate actively in class work, which will give them the opportunity to apply theoretical concepts to realistic situations and to develop their problem-solving skills. In order to benefit from this approach, it is important that all students come to class fully prepared.

<b>Assessment</b>	<p><b>Attending students</b>  Final Exam (50%):  The final exam is a combination of problems, cases and essay questions.  Assignment (40%):  Just one case will be assigned during the semester. It will be announced one week in advance. <b>No late assignment will be accepted.</b>  Class participation (10%):  Participation points will be awarded on the basis of the quality of the participation of each student to class discussions.</p> <p><b>Non-attending students</b>  Final Exam (100%)</p> <p>The problems included in the final exam are aimed at assessing the acquisition of knowledge and understanding and the ability to apply them to new situations. The essay questions of the exam and the case assignments also evaluate the ability of the student to make judgements and to communicate effectively in writing. The case assignments also measure the student's ability to search for the relevant regulatory and economic information that apply to a specific situation. Class participation is aimed at assessing the ability of students to apply knowledge and understanding, to make judgements and to communicate effectively orally.</p>
