<b>Prerequisites</b>	<p>Students without a background in Economics are strongly suggested to actively attend the “preparatory course” in Economics organized at the beginning of the semester. At the end of the prep course, an exam will be organized, in order to test the basic knowledge of the students. The test is aimed at making students aware of their knowledge. There are no negative consequences in case of “fail”, only the student is advised to discuss with the Lecturing Assistant and the Professor how to improve his/her knowledge. In case of “pass with distinction”, students are awarded an additional point in the final exam.</p>
