	M2: Modul 2 aims at introducing students to the fundamentals of the welfare state, its developments in a comparative perspective, its recent trends and current dilemmas. The interplay of family, market and state in welfare provision is also comparatively addressed. The main areas of social policy are introduced. The module also addresses the development of social work as a product of modern welfare regimes, the impact of welfare state developments on social work practice and the role of social work in policy implementation and policy practice.

Learning outcomes	 <u>Knowledge and understanding</u>: Basic knowledge of and understanding of social work as a profession and as a discipline, its mandates and fundamental notions, its theories and normative reference elements. Basic understanding of fundamental social policy areas and issues; knowledge of welfare arrangements, traditions and models; main current developments and challenges. <u>Applying knowledge and understanding</u>: Application of the acquired knowledge when dealing with social issues and policy challenges, as well as with regard to the practice of social work. <u>Making judgments</u>: Development of professional analysis and reflection skills as well as the ability to critically assess how social (policy) issues are dealt with, and managed, in the practice of social work. <u>Communication skills</u>: Development of technical language (social work practice) and of the related skills supporting students in technical communication, summaries and argumentation. <u>Learning skills</u>: Systematic acquisition of the fundamentals in social work and social policy; and their utilization in reflexivity

Assessment	MODUL 1: written and oral exam + coursework MODUL 2: two different assessment routes are offered

1st option: Standard assessment (all students): two steps

1. Individual project work (50% of the final marks): 3-4 pages mini-essay, with critical reflections, to be delivered not later than 7 days before the exam. The theme can be selected by the students from a list of subjects prepared by the instructors (with a couple of short related readings). The list will be available in the Reserve Collection at the start of the course;

2. Final written test (50% of the final marks): 30-40 minutes test that includes closed-ended multiple choice questions and a few short open-ended questions.



2 nd option: Attending students (optional)*: 3 steps Attending students* can opt for this alternative assessment procedure:
1. Individual project work (50% of the final marks), as specified for the standard assessment;
2. Final written test (25% of the final marks): 30-40 minutes test as specified for the standard assessment;
3. Active participation in class and/or on the Ole-Moodle platform (25% of the final marks). It includes the discussion of a few preparatory readings.
<i>Important notes for M2 (all students, all assessment routes):</i> A positive evaluation of both the individual project and the final written test is needed in order to pass the exam, irrespective of the overall weighted average marks attained. * Students who attend less than 50% of module 2 lectures – as from the course register – do not qualify as attending students. Their evaluation will follow the standard assessment route.
Deutsch (Module 1) and English (Module 2)
Marks for the whole assessment procedure and for its singles steps are in the range 0-30. Sufficiency is attained when marks are greater than or equal to 18/30.
Final marks for the course are computed as the average of M1 and M2 marks.
Assessment criteria In general: acquisition of the course contents as well as their understanding and reflexive application in relation to current questions and problems.
In written work (open questions in written exams, individual project's mini essay), attention is paid to references to specialist literature and course contents, logical structure, clear argumentation, ability of critical analysis and formal correctness.
In written test (closed-ended questions) attention is paid on knowledge of the course key themes and concepts, accuracy and ability to evaluate.
In the oral examination, particular attention is paid to communication and reflection skills.
In active participation, is paid attention to: the ability to summarize in own words, to critically discuss assigned and preparatory readings, to gain insights from exemplary readings and exercises, and to the ability to make connections between themes and concepts discussed in the course.
