Course description	The course belongs to the class "caratterizzante" (module 1), "di base" (module 2) and "affine integrativa" (module 3) in the curriculum in Design.
	<i>Module 1 – Produktdesign</i> DF
	Ein junger Designer, der sich der Berufsrealität nähert, muss nicht darauf warten, dass ihm ein Unternehmen einen direkten Auftrag erteilt, sondern kann aus eigener Initiative neue Projekte vorschlagen. Er muss jedoch klare Vorstellungen haben und zunächst seine eigenen Interessensgebiete und den Beriech definieren, in dem er arbeiten sowie mit welchem Unternehmen er (fiktiv) zusammenarbeiten möchte. Er sollte eine besondere Sensibilität entwickeln, um die unterschiedlichen Philosophien/Kulturen der jeweiligen Unternehmen zu verstehen und "Lücken" innerhalb bestehender Kollektionen finden.

Diese sehr offene und freie Form des Projekts ist eine Übung im selbständigen Arbeiten, die besondere Aufmerksamkeit in der Organisation der eigenen Arbeit sowie ein gutes und verantwortungsvolles Management der eigenen Zeit erfordert.
EN Generally a young designer who approaches the reality of the profession is not forced to wait for a company to give him a direct assignment but can, on his own initiative, come forward proposing new projects.
However, he must have clear ideas and first of all identify his fields of interest and the sector in which he wishes to enter and then which companies he would like to collaborate with. He needs to develop a particular sensitivity to understand the different philosophies of the companies he is considering and to perceive the "gaps" within the existing collections.
<ul><li>ATELIERprojekte_SS24 aims to hone these skills and to tackle the necessary path step by step:</li><li>to define one's own field of intervention after a careful;</li></ul>



<ul> <li>investigation into the world of objects and services that surround us;</li> <li>understand how a company builds a collection, if and with which designers it collaborates and how it presents itself on the market;</li> <li>perceive the "empty" spaces to fill in the collections/catalogues;</li> <li>think and define a concrete project or service;</li> <li>visualize it through models of proportion, function or mock-up;</li> <li>prepare an appropriate presentation, also in writing.</li> </ul>
Each student will have the task of defining his or her own theme and developing it during the semester. The points from which to start can be the most varied: from the exploration of urban spaces to the reinterpretation of one's own personal environment. In any case, students will be encouraged to take a critical look at the reality in which they live.
This very open and free form of project is an exercise in self-employment that requires particular attention to the organization of one's work and a good and responsible management of one's time.
Module 2 – Digital Fabrication

Through experiential learning, they will gain in-depth hands-on knowledge about various fabrication techniques while discovering meaningful connections between the digital and analog worlds. This module, side-by-side with the project, offers a dynamic exploration of how digital



	design practices intersect with hands-on fabrication, preparing students to adapt and innovate in today's design landscape.

List of topics covered	<b>Module 1</b> Design of everyday objects for the home, office, person, travel, etc. Products to be produced in eco-sustainable materials that can be produced for the most part with production systems with low technological complexity.
	<b>Module 2</b> The course aims to create practical and shared experiences built through various formats and situations that intersect and combine disciplines, modules, and spaces. Through assignments covering different techniques both inside and outside the university, as well as visits and guest speakers showcasing differences in production methods and tools, the course seeks to explore the coexistence or divergence of digital and analog production methods.
	<b>Module 3</b> The topics are organized along a different series of lectures that inquire into different aspects of the relation that exists between a designer and all actors that take part in the production of the artifact: companies, manufacturers, the market's agents, the critical apparatuses, etc. Each lecture will be centered around a specific company or figure. Each lecture will allow the students to understand how to position themselves in various and complex markets and production chains, in



	which each agent corresponds to an articulated series of specificities.
	Lectures will be on (list might slightly change): Kartell and the intuition of the plastic; Poltronova and the invention of a new way of sitting; Scandinavian design companies: exploring the reasons for a worldwide success (the role of Elizabeth Gordon and Frances Knoll); Light: Foscarini, Artemide, Floss; Self-initiated projects, does it make sense?

	<b>Module 3</b> The exam is included as integral part in the final presentations concerning the project PD-2a with particular reference - on one hand - to those contents that have been explored, presented and discussed in the classroom and - on the other hand - to those ones documented in the digital Reserve Collection of "Theories and Languages of Product Design: Project 2a". The exams' evaluations will particularly focus onto the students' ability and originality concerning the integration of conceptual and theoretical topics and characteristics into their final presentations of the projects.

Documentation is an integral part of the exam. The documentation must include visual documentation and an abstract of the project.

The final assessment is based on the content of all the exercises according to the following criteria:

## Module 1

The quality and clarity of the research, the creativity and the originality of the design concept, the quality and clarity of the design process, of the development and realization of the project such as the professionalism and consistency of the presentation and documentation.

Also contributing to the final evaluation will be the initiative and the personal commitment in the atelier, in the research and the study and the participation in the project or the continuity, the attention and the curiosity demonstrated.

## Module 2

The evaluation will consider factors such as creativity and originality in approaching exercises, adherence to deadlines, curiosity, and motivation in addressing short and secondary projects, as well as the quality of the design process.

Additionally, the final assessment will take into account the commitment to the main project and participation in the work group, research, and study, as well as the demonstrated attention, curiosity, and continuity in projects.
