Course description	The course belongs to the class "caratterizzante" in both major in Design and in Art. "Anthropology allows you to be curious about everything, from poetry to history to climate change models. It's a difficult discipline, but we can give answers to problems in a way other disciplines don't. "(Andrew Mathews). This course provides an introduction to anthropological theory and method and demonstrates its relevance to a range of questions about art, design and more: Anthropology is the discipline par excellence that addresses questions of relationships, practices, knowledge and perceptions of meaning in different cultural contexts. The study and analysis of practices through ethnography is at the center of its interest. In the course we will contextualise cultural plurality and diversity in art and design by addressing urgent issues of our present. The course provides students with analytical and methodological tools and concepts for ethnographic research into the perspectives and experiences of other people and more than human beings.
Specific educational objectives	 Knowledge and understanding have acquired a solid cultural heritage in which technical and media skills are combined with theoretical reflection, a necessary prerequisite for approaching the complex phenomena of today's



	society with awareness and being prepared to act as active participants. have acquired the ability to grasp and analyse contemporary cultural and social phenomena that characterise design and art. The course aim is to integrate anthropological perspectives into perception and analysis of cultural crafts and artistic expressions. Additionally, the course will prepare students for a critical engagement with scientific texts and help them develop appropriate academic writing skills. The critical reflection on concepts such as human relationship with nature (ecology), the question of 'beauty' and will lead to new understanding of bottom-up approaches and grounded empirics.

Assessment	Assessment is based on a presentation in class, written minutes on two main texts and on an ethnographic exercise. The final oral exam will be used to verify the capacity to apply anthropological concepts and instruments relevant to art and design. Non - attending students will write a critical paper about an ethnographic film and a paper based on main texts discussed during lecture.
