She was appointed as a researcher at the University of Bologna in 1999.

In 2004 she became Associate Professor.

She is Full Professor since 2009.

Partiti e politiche da Berlusconi ai populistici*, Bologna, Il Mulino 2022, co-authored with Pedrazzani, Andrea; Pinto, Luca) and edited two volumes (in English: *Intraparty Politics and Coalition Governments* (with Kenneth Benoit, London, Routledge 2009) and *A Natural Experiment on Electoral Law Reform. Evaluating the Long Run Consequences of 1990s Electoral Reform in Italy and Japan* (with Bernard Grofman, New York, Springer 2011). Recently she co-edited the Italian edition of the textbook by Clark, W.R., Golder M. and Golder S. *Principles of Comparative Politics (Principi di scienza politica*, McGrawHill 2022).
