Following the completion of my PhD, I taught Microeconomics and Macroeconomics at the University of Padova (Department of Humanities) from 2013 to 2016. This compulsory course was part of the Bachelor's program in Cultural Mediation. Teaching students without a mathematical background presented a unique challenge, as traditional methods involving formulas, proofs, and equations were not easily understood. Over time, I

developed strategies to convey key economic concepts by emphasizing practical examples, visual aids, and relatable, everyday experiences. For the Microeconomics component, I incorporated online experiments to simulate competitive markets, demonstrating the convergence to competitive equilibrium. My efforts resulted in high student evaluation scores, and students successfully grasped fundamental concepts such as consumer theory, production, game theory, and macroeconomic models like IS-LM and AS-AD.

In 2015, I served as a teaching assistant to Professor Giacomo Calzolari (University of Bologna, European University Institute) for an advanced Microeconomics course focused primarily on Game Theory. This course, part of the Laurea Magistralis in Economics—Bologna's top-ranked Master's program in Economics—deepened my understanding of how to support students through complex material. Similarly, in 2017 and 2018, I worked as a teaching assistant for Professor Salvatore Piccolo (University of Bergamo) in both Microeconomics and Macroeconomics, further refining my ability to address students' needs during exercises and effectively collaborate with course coordinators to ensure a cohesive learning experience.

I also taught courses in Microeconomics, Industrial Organization, and Game Theory at the bachelor's, master's, and PhD levels at the University of Bozen-Bolzano, predominantly during the COVID-19 pandemic. During this period, I developed techniques to engage students with diverse educational and linguistic backgrounds and created methods to facilitate active participation in online settings. Student feedback for these courses was consistently positive.

In recent years, I have continued to refine my teaching approach. I prioritize fostering an inclusive learning environment that encourages student engagement and inquiry. My primary teaching responsibility has been the Microeconomics course for the PPE/EPE Bachelor's program, where students study Economics, Politics, and Philosophy/Ethics. In addition to covering the fundamental models of Microeconomics, I emphasize the rationale behind these models, their advantages, and their limitations. I have incorporated advanced topics such as the axiomatic derivation of utility theory and different equilibria in Game Theory, while also expanding beyond formal models to include seminal papers and advanced contemporary readings in each session. Although these readings are not mandatory, they enrich students' understanding of the material and its real-world applications.

In my courses—such as Microeconomics for EPE, Public Economics, and Microeconomics for PhD students—I integrate student-led projects that involve reading and critically engaging with state-of-the-art research literature. Topics presented by first year students of EPE in 2024 included: The microeconomics of Tobacco and Alcohol, The Fall of the Labor Share and the Rise of Superstar Firms,The Edgeworth Box, Sellers and incentives: in-kind bonus "Bonus cultura", How govt regulation affects competition and price elasticity of supply and demand in the tobacco industry, The effects of inflation on the budget set of families, Real world case studies of positive externalities, The Lindahl tax. This approach, introduced even to first-year bachelor's students, has been well-received, offering them an early opportunity to explore academic research and develop presentation skills.

Research and scholarships

My research interests are in Political Economy, Public Finance, Public Economics, Development Economics, Industrial Organization. My research focuses on the incentives that drive the implementation of different policies by politicians, legislators and autocrats, and how citizens and special interest groups can influence those incentives. The recent history of modern democracies in western societies shows that it is not possible to propose models and policies that target economic efficiency without understanding how these policies interact with the political environment, which can in principle subvert the proposed objective. Through the use of theory and causal empirical identification techniques, my work aims at shedding light in the black box that takes in economic variables and produces political outcomes, and the other way around.
