that the **Faculty of Science and Technology** tenders a competition for a scholarship for research activities by qualifications and interview according to the following modalities.

1. Description

Detailed description of the activity to be conducted from the scholarship recipient:

The successful candidate will take care of the computational analysis and management of soil biological fertility including, but not exclusively, enzymatic activities, microbial biomass, QBSAR and QBSE quality indexes, mycorrhization index, meta-taxonomy.

The candidate has experience in the statistical handling of complex experimental designs and of the appropriate software the handle data, including but not exclusively, the R platform.

The candidate will support field and laboratory activity and will regularly participate to field trips and sampling. The candidate will be able to travel independently to reach the Technology Transfer Center



of the Fondazione Mach and the experimental fields located in the provinces of Trento and Bolzano.

2. Requirements for competing in the selection procedure

For the competition to the selection procedure, the following requirements are requested, under penalty of exclusion:

- a four-year/five-year undergraduate degree (Bachelor) or a Master degree or an equivalent qualification in biotechnology, agricultural-, biological-, environmental or forestry science or equivalent titles. Study titles gained abroad, which have not been declared equivalent according to the current legislation will be evaluated solely for the purposes of selection by the commission of selection. For this purpose, applicants must attach to the application form, the necessary documents for the selection commission to decide on the request for eligibility.
- Scientific and professional curriculum, suitable for performing the above described research activity which shows in particular the knowledge of the fundamentals of the computational analysis and management of complex data and the use of appropriate data-elaboration programs, especially the R platform
- driving license B.

3. Procedures and deadline for presenting the application

The application may be presented in the following ways:

The acceptance of the application is authenticated by the date of the entry stamp of the faculty administration. The submission is not authenticated by the date of the post stamp.

The administration does not assume responsibility for post and/or informatical errors or errors attributable to third parties, unforeseeable circumstances or major force.

Applications may be written in Italian or English.

Following documentation must be attached to the application:



- 1) a scientific and professional CV, signed and dated, where the candidate also points out on the skills and aptitudes that are relevant to his/her work on the research programme, as described in art. 1;
- 2) any publications, qualifications or certificates deemed useful to demonstrate the competence of the candidate in relation to the mentioned programme together to a list of the presented titles;
- 3) copy of a valid identity document (identity card, passport, driving license).

Publications, titles or other certificates issued by <u>Italian Public Administration or Institutions must be presented in one of the following was:</u>

- a) <u>a declaration in lieu of an affidavit</u> as per article 47 of D.P.R. 28 December 2000, no. 445. In such a case, applicants must provide:
- 1 photocopy of each qualification;
- 1 declaration, following the model provided in attachment 'B', in which the applicant declares, under his/her own responsibility, that the copies of qualifications attached, described in detail with reference to their issue date, place and institution where the qualification(s) was/were obtained, complies to the originals in his/her possession;
- 1 photocopy of an ID document.
- b) <u>a declaration in lieu of certificates</u> as per article 46 of D.P.R. 28 December 2000, no. 445. In such a case, applicants must provide:
- 1 declaration, following the model provided in attachment 'B', in which the applicant declares, under his/her own responsibility, that s/he possesses the qualifications, described in detail with reference to their issue date, place and institution where the qualification(s) was/were obtained: this declaration acts simultaneously as list of publications, therefore this list must not additionally attached.
- 1 photocopy of an ID document.

The University can neither accept nor request certificates issued by Italian public administration/institutions. Therefore, any such certificate, if it is attached to the application, will not be taken into consideration for the selection procedure as per this advertisement.

Any qualifications/certificates issued by private institutions* or issued abroad can be produced:

- a) as the original(s), or
- b) as an authenticated copy or
- c) as a declaration in lieu of affidavit or <u>as a declaration in lieu of certificates</u> as per article 46 or 47 of D.P.R. 28 December 2000, n. 445 (cfr. attachment 'B')

<u>Non-EU citizens</u> may use the said declarations limited to cases where states, facts and personal qualities can be certified by Italian public or private entities.

Not signed application by the applicant or application delivered after the deadline or in a not valid way will not be considered or admitted.

4. Selection procedure and selection committee

The selection committee is constituted of the scientific responsible of the research and by other two members appointed by the Faculty Council of the Faculty of Science and Technology among the professors and researchers.

The assessment of the candidates is per qualifications and interview.



For the evaluation of the <u>qualifications</u> the following assessment criteria are applied (max. 60 points):

- 1) Max 50 points for the qualifications
- 2) Max 10 points for the publications

For the evaluation of the interview, max. 40 points are applied.

The requested minimum score to declare the candidate suitable for the position has been defined by the Selection committee in n. 30 points of 100.

The interview will take place on 27.03.2018, 16.00 o'clock, in office K3.07 Building K, Piazza Università 5, 39100 Bolzano.

Candidates are required to be present at the place and date indicated, under penalty of exclusion, with a valid identification document. This call is equivalent to the notification of the convocation to the interview and therefore no other direct communication to the candidates will follow.

The judgement of the Commission cannot be appealed.

5. Publication of the ranking list

6. Awarding of the scholarship

The winner will be notified by a written communication about his/her assignement of the scholarship. At the end of the scholarship, the scholarship recipient must transmit a final report about the research activity to the Dean of the Faculty, that has previously been approved by the scientific responsible of the research and/or the scientific co-responsible.

In case of scientific publications edited by the scholarship recipient and deriving from the activity conducted within the scholarship, the holder of the scholarship is required to mention the financial contribution of the Fondazione Edmund Mach.

7. Incompatibility

The scholarship is incompatible with research scholarships or with other scholarships at any title conferred, with exception of the one foreseen for the integration of a stay abroad, neither with salary from public or private employment, even if it is a temporary employment, except for the possibility that the scholarship recipient will be placed by the employer on unpaid leave.

It cannot be combined with payments for performance of self-employment appointments conferred by the University.

The scholarship can not be conferred to those who are related to marriage, or related within the fourth degree of kinship, to the Rector, the general Director, a member of the University Council, the responsible of research or a professor or researcher working for the department which hosts the programme to which the bursary is referred.

8. Loss and withdrawal

The right to the scholarship will be lost for those who, within the fixed deadline, do not accept the scholarship or who do not begin the activity within the indicated term. Only delays due to grave health reasons or to force majeure duly proved are justified and admitted.

The loss of the scholarship also involves not justified interruptions of the research activities, or cases in which the scholarship recipient is responsible for serious and repeated defaults.

The scholarship recipient may withdraw from the contract by communicating to the Dean, who declares the loss of the scholarship. The fees paid for the effective period of fruition of the scholarship up to the revocation date are expected.



9. Legal nature of the scholarship

The scholarship activity of this announcement does not constitute an employment relationship. The scholarship will be subject to the tax treatment and pension scheme defined by the current legislation at the date of payment.

10. Dispositions regarding the protection of the personal data

In application of art. 13 of the D.Lgs. 196/2003 "Laws regulating the protection of personal data," the Free University of Bozen-Bolzano, which is owner of the personal data regarding the selection procedure, informs that the personal information gathered during the proceedings will only be used to the purpose of the present selection with the use of informatic procedures and paper storage of related acts.

He/she will however be able to access the disclosed information, under the provisions of art. 7 of D. Lgs. 196/2003 and the right to actualize, correct, complete or cancel erroneous or incomplete data or collected not compliant to the right, and not to oppose for legitimate reasons their treatment.
